The Constitution of Beth Tzedec Congregation ("the Congregation") states: "Every member in good standing entitled to vote at a General Meeting may appoint any other member of the Congregation as a proxy holder. A proxy shall be in writing, executed by the member in the form prescribed from time to time by the Board and shall be witnessed by any person who is a member of the Congregation, but excluding any persons employed by the Congregation and all candidates in the election, their spouses, children, siblings and parents. To be valid, a proxy must be delivered to the Congregation no later than 48 hours prior to the General Meeting. This delivery by facsimile transmission or e-mailed file (such as a pdf, TIFF or JPEG) to the Congregation shall be deemed to be equivalent to the delivery of an original executed document." The election referred to in this provision is the election to the Congregation's Board of Governors. The witness signing below represents that s/he is eligible to witness this proxy within these terms.

Section 11 of Article V of the Constitution states: "A ballot for any election of members of the Board of Governors shall be void unless it is marked for candidates which in the aggregate represent no less than 50% and no more than 100% of the number of positions to the Board of Governors which are to be filled by that election."
