## BETH TZEDEC CONGREGATION NOTICE OF ANNUAL GENERAL MEETING OF THE MEMBERS

**Take Notice** that the Annual General Meeting of the Members of Beth Tzedec Congregation ("the Congregation") will be held in the Banquet Hall of Beth Tzedec Synagogue, 1700 Bathurst Street, Toronto, Ontario on Thursday, the 30<sup>th</sup> day of May, 2013 at 7:30 p.m. for the following purposes:

- 1. To approve the Minutes of the Annual General Meeting of the Members of the Congregation held on May 31, 2012;
- 2. To elect nine members of the Congregation to the Board of Governors for a two-year term;
- 3. To approve the Annual Financial Statements of the Congregation for the year ended June 30, 2012;
- 4. To appoint Auditors and Accountants and to authorize the Board of Governors to fix their remuneration;
- 5. To confirm the amendment to the By-laws of the Congregation passed by the Board of Governors on May 9, 2013, specifically confirmation of the following:

The By-laws of Beth Tzedec Congregation are hereby amended by replacing Sections 21 and 22 of Article V therein with the following:

21. Every member in good standing entitled to vote at a General Meeting may appoint any other member of the Congregation as a proxy holder. A proxy shall be in writing, executed by the member in the form prescribed from time to time by the Board and shall be witnessed by any person who is a member of the Congregation, but excluding any persons employed by the Congregation and all candidates in the election, their spouses, children, siblings and parents. To be valid, a proxy must be delivered to the Congregation no later than 48 hours prior to the General Meeting. This delivery by facsimile transmission or e-mailed file (such as a pdf, TIFF or JPEG) to the Congregation shall be deemed to be equivalent to the delivery of an original executed document; and

6. To transact such other business as may properly come before the meeting or any adjournment thereof.

#### Explanation of purpose number 5 above:

The former section 21 included a requirement that the proxy "shall be witnessed by any person who is a member of the Congregation and who is authorized to witness passport applications, or is a teacher, professor or professional educator, but excluding any such persons employed by the Congregation and all candidates in the election, their spouses, children, siblings and parents". Witnesses are no longer required in passport applications rendering meaningless the phrase "who is authorized to witness passport applications". This amendment replaces the passport witness requirement with a requirement that it be witnessed by any person who is a member of the Congregation, but excluding classes of persons that were provided for in the previous section 21. This amendment also brings the Congregation into the 21st Century by permitting delivery to the Congregation by e-mail.

#### **PROXY APPOINTMENTS**

A member has the right to appoint a proxy in the manner set forth in the Constitution, to attend the Annual General Meeting and act on his or her behalf to the extent and with such powers as may be conferred by the instrument of proxy.

Pursuant to the provisions of the Constitution, proxies, to be valid, must be delivered to Beth Tzedec Congregation at 1700 Bathurst Street, Toronto, Ontario M5P 3K3 by no later than 7:30 p.m. on Tuesday, May 28, 2013. Delivery by facsimile transmission or e-mailed file (such as pdf, TIFF or JPEG) to the Congregation shall be deemed to be equivalent to the delivery of an original executed document.
